Imphal, the 4th October, 2017.

No.DC(IW)7/2/GP-Elec/2017: In order to regulate movement of traffic on the day of dispersal of polling parties on 6th October, 2017 and return of polling parties after completion of poll on 7th October, 2017 in connection with the ensuing 7th General Panchayat Election, 2017, the following arrangements are hereby made:

On 6th and 7th March, 2017 (from 7.00 a.m. onwards)


- 1) All vehicles belonging to Observer, his escort and Liaison Officer, DC/DEO, ADM, SDO (RO), AC to DC, BO (Accounts), SDCs, officers and officials of external & internal electricity teams and medical team shall be parked inside the Office Complex of DC Office, Lamphelpat.
- 2) All vehicles belonging to the officers/officials detailed on election duty with the DC/DEO, SDO/RO shall be parked in the office complex of Excise Department, Lamphel.
- 3) All vehicles belonging to the polling personnel shall be parked at the office complex of the Registrar Co-operative Society, Excise Department and Family Court Complex.
- 4) On the day of dispersal i.e. 6th October, 2017, the polling personnel shall alight from their private vehicles at the meeting point of Laishram Leirak road and RIMS-DC road. Thereafter their vehicles can be parked at the parking lots identified above or may proceed towards the road leading to NG College by lane.
- 5) The vehicles of officers and officials of the office of the Chief Electoral Officer, Manipur may be allowed to pass through the route leading to its office on production of their service I/Card.
- 6) Further, all vehicles coming towards DC office from Laishram Leirak and Uripok Kangchup Road shall be regulated at Laishram Leirak Machin at the Uripok Kangchup Road junction.
- 7) The route leading from RIMS Ring Road towards DC office, Imphal West shall be restricted at the meeting point of N.G. College by-lane and the ring road near the gate of Directorate of Commerce & Industries, Lamphelpat.
- 8) The route from Langol Games Village towards DC office shall be regulated at the meeting point of Chingangbam Leirak/Mohon Motors with the ring road near the north western corner of CRPF Camp.
- 9) The route coming from the direction of Minor Irrigation Office towards DC office shall be restricted at the gate of the Family Court Complex at Lamphelpat.
- 10) The polling personnels shall obtain details of the vehicles allotted to them for poll duty from their respective ROs and shall alight their respective vehicles as detailed below:
 - a) For Patsoi : Ball Lampak near Mohon Motor
 - b) For Wangoi : Along the western boundary of DC Office complex leading to the office of CEO, Manipur
 - c) For Lamsang : Along the eastern boundary of DC Office complex, traversing in front of Education (S) department and family court.

On 7th October, 2017 (from 3.00 p.m. onwards)

- 1) Vehicles transporting polling personnel and polled material shall halt at the Main Gate (Southern Gate) of DC Office. The polling personnel shall alight at the main gate. Thereafter the vehicles shall proceed towards Mohon Motors Workshop and follow the route that leads to Uripok Kangchup Road through the Thoudam Leirak.
- 2) Those who park their vehicles at various parking sites (except those inside the office complex of DC office, Lamphelpat) shall take their vehicles out from the parking sites after completion of the election duty positively.
- 3) The vehicles of officers and officials of the office of the Chief Electoral Officer, Manipur may be allowed to pass through the route leading to its office on production of their service I/Card.
- 4) Further, all vehicles coming towards DC office from Laishram Leirak and RIMS shall be regulated at Laishram Leirak Machin at the Uripok Kangchup Road junction.



- 5) The route leading from RIMS Ring Road towards DC office, Imphal West shall be restricted at the meeting point of N.G. College by-lane and the ring road near the gate of Directorate of Commerce & Industries, Lamphelpat.
- 6) The route from Langol Games Village towards DC office shall be regulated at the meeting point of Chingangbam Leirak/Mohon Motors with the ring road near the north western corner of CRPF Camp.
- 7) The route coming from the direction of Minor Irrigation Office towards DC office shall be restricted at the gate of the Family Court Complex at Lamphelpat.
