**O R D E R S**  
Imphal, the 9<sup>th</sup> October, 2017

No.DC(IW)7/2/GP-Elec/2017: In order to ensure smooth counting of votes of the 5<sup>th</sup> General Panchayat Election, 2017, in respect of Imphal West District, which is scheduled to be taken up at the counting halls located in the office complex of Deputy Commissioner, Imphal West at Lamphelpat, the following security arrangements are hereby made to be implemented in and around the above office complex with effect from 2.00 pm of 10<sup>th</sup> October, 2017 till the counting process is completely over.

**1. ENTRY INTO THE OFFICE COMPLEX:**

The following categories of persons as indicated in the table below are allowed to enter past the Southern gate (main gate) into the office complex of Deputy Commissioner, Imphal West District at Lamphelpat:

3	Candidates, their Election Agents and Counting Agents holding valid Identity Cards issued by the SDO/RO	No restriction	Not allowed inside DC Office campus
4	Counting Supervisors, Counting Assistants, Counting Peons holding valid Identity Cards issued by the SDO/RO	No restriction	Not allowed inside Counting Hall
5	Superintendent of Police, Imphal West, Police Nodal Officer, other police officials detailed for duty by SP, Imphal West, Superintendent of Police, Traffic and officials detailed for duty by SP Traffic, Officers detailed for duty by Superintendent of Police, CID, Officers and officials of DEO and SDO/RO detailed for election duty holding Identity Cards issued by DC/DEO or SDO/RO	Cannot enter Counting Hall	Not allowed inside Counting Hall
6	District Information Officer, I/W and staff of DIPR, Manipur detailed for election duty, Accredited media persons	Can witness Counting Hall proceedings but cannot enter Counting Hall	Mobile phone cameras can be used to cover counting process but cannot be used for communication. In case separate cameras are being used, mobile phones to be left at Media Centre.
7	All other Officers and Officials of offices located in DC Office Complex, Lamphel	Cannot enter Counting Hall	Not allowed inside Counting Hall
8	Voters coming to cast Postal Ballot	Allowed to move upto Designated Centre at concerned RO office for casting of postal ballot papers upto 08.00 a.m. He/she will leave immediately after casting vote	Not allowed into DC Office campus



Further, the entry of the Counting Agents shall be so regulated as to ensure that there shall be only one counting agent per counting table of the concerned Counting Hall plus one more agent for RO Table (Counting Hall) to attend to the counting of Postal ballot paper for each contesting candidate inside the office complex at any point of time.

**2. ENTRY GATE:**

Only the Southern Gate (Main Gate) shall be used for entry and exit of the above categories of Officers/Officials/Candidates, their Election Agents and Counting Agents. All the other gates shall be closed.

**3. VEHICULAR/TRAFFIC REGULATION:**

I) Vehicles of the following categories of officers and officials shall be parked at the South-Eastern side inside the office complex of Deputy Commissioner, Imphal West, Lamphelpat.

- a) Secretary, SEC Manipur.
- b) DC/DEO, Addl. DM, AC to DC, SDO/RO, SDOs and SDCs.
- c) Observer and his security personnel and Liaison Officer.
- d) Superintendent of Police, Imphal West, Superintendent of Police (Traffic), Police Nodal Officer, Police Officer above the rank of ASI as may be detailed by SP, Imphal West
- e) Officials and staffs of SEC, Manipur.
- f) Officers and officials of DC/DEO's office on election duty appointment/authorized by DC/DEO or SDO/ROs on counting duty.
- g) Officers and officials of offices located in DC Office Complex, Lamphel
- h) District Information Officer, Imphal West and staff of DIPR, Manipur detailed for election duty.
- i) Counting Supervisors, Counting Assistants, Counting Peons and other officers/officials on counting duty appointed by SDO/RO.

II) All the vehicles belonging to the contesting candidates and their election agents shall parked inside the office complex of the Excise Department, Manipur at Lamphelpat.

III) All the outgoing vehicles from the parking areas shall move out only through the RIMS Ring Road either toward RIMS and then take Uripok Khumanthem Leikai Leirak to reach Uripok Road or N.G. College by-lane.

IV) No other person/vehicle except for the categories of person at SI No. (a) to (i) above shall be allowed entry beyond the following points.

- a) Gate near Directorate of Commerce & Industries, Manipur, Lamphel.
- b) Meeting Point of Chingangbam Leirak/Mohon Motor Leirak & Ring Road near North Western Corner of CRPF Camp at lamphel.
- c) Entry point of Laishram Leirak on Imphal-Kangchup Road.
- d) Gate near Court's Complex at lamphelpat.

V) All the officers, officials and vehicles belonging to Election Department, Directorate of Settlement & Land Record and Directorate of Employment Exchange, Manipur as well as private vehicles and public going to Langol Games villages and Imphal Kangchup Road shall pass through the Chingangbam Leirak/Mohon Motor Workshop leirak.

VI) No person except the Security Personnel on duty should be allowed to carry arms and ammunition inside DC Office Complex.


VII) No match box, inflammable substance, stick, knife, blade or any other sharp instrument etc. which could be used as a weapon should be allowed to be taken inside DC Office Complex.

VIII) All the Counting Agents of each of the contesting candidates shall be made to wait at the Laishram Khullen Leikai Community Hall until they are called for by the SDO/RO concerned.
