Subject:- Revised assessment of damages as on 15<sup>th</sup> July, 2017

Sir,

Kindly refer our earlier letter No. 8/3/2017-(R&DM)Pt. dated 12<sup>th</sup> July, 2017 on the above subject by which the Memorandum for damages was submitted. In the Memorandum, it was also mentioned that the flood is still continuing and figures may go up. Meanwhile, the IMC team has landed in Manipur on 13<sup>th</sup> July, 2017 and has visited several places by road as well as aerial survey. During last few days, the assessment of damages has further increased and as per the reports received till 15<sup>th</sup> July, 2017, the total amount of damages are approximately Rs. 213.71 crore. The revised assessment in the prescribed Performa is also enclosed herewith.

During the discussion with the team members, they have desired to see the list of victims whose houses have been damaged either fully or partially damaged. As the whole machinery at the district level is still busy 24x7 tackling with flood and relief management, the total data for the all victims is being collected, which may take a little time. However the no. of houses etc. damaged till 15<sup>th</sup> July, 2017 were already counted and identified and other details are being collected. However, as some Deputy Commissioner have partially submitted the list, the same is also enclosed herewith for your kind reference. The full list with details will be sent as soon as it is completed.

In view of the above, it is again requested to kindly consider to sanction the revised figure of **Rs.213.71 crore** as damage assessment for Manipur till 15<sup>th</sup> July, 2017 i.e. till the date of departure of IMC team to Delhi.


